



## City of Moorhead Right of Way Permits – Contractor Registration


1. Go to <https://moorheadcm.novotx.com/Account/Login>, and select ‘Contractor Registration’:



2. Select ‘Create an Account’ from the bottom of the screen:



3. Enter all the required information and select 'Create Account'. This information should be specific to the actual user. In this new program, each contractor is authorized to have multiple user accounts associated with the primary contractor account. The information on the screen should be specific to the person who is registering for the account:





## Welcome

A City of Moorhead right-of-way permit is required for all excavation and directional drilling work.

In addition, a permit is required for installation of all driveway approaches, culverts, sidewalks, or curb and gutter within the public right-of-way.

Before an application for right-of-way construction will be considered, all applicants must have a current **Contractor Registration** account on file that includes a minimum \$10,000 contractor bond (Payable to the City of Moorhead) for all driveway approaches, culverts, sidewalks, or curb and gutter permits, or a \$25,000 contractor bond (Payable to the City of Moorhead) for all excavation and directional drilling permits. In addition, a current certificate of liability insurance must also be on file (City of Moorhead listed as additional insured).

Once your Contractor Registration account has been approved, you can apply for the applicable permits through the **Connect Portal**.


