Please describe why you are interested in being appointed.

I am interested in being appointed Councilman because I grew up in Moorhead, and I believe there is something special about living in Moorhead. There's a real community here of people bound together by our collective appreciation, not just for the FM area, but for Moorhead specifically.

I am impressed with the excellent work I see in our civic leaders and city government. As a Councilman, I will contribute my skills, my leadership, and my love for the community of Moorhead. And I will serve on an already excellent City Council.

Moorhead is on a remarkable growth trajectory, and I desire to contribute to that growth and ensure it continues well into the future.

Provide a brief description of your background and experience relevant to appointment.

In my current role, I am the Multimedia Lead for the High Impact Institute and Dakota Medical Foundation. Previously, I was a Visual Content Strategist for Concordia College. In both of these roles, I oversaw video production from beginning to end.

The key to successful video production is leadership. On large video projects, it is not unusual for me to spend as much, if not more, time on planning, communicating, budgeting, and leading teams than I do behind the camera or in front of an editing workstation. Meeting with key stakeholders, having crucial conversations, and decision-making are every bit a part of my day-to-day work life as shooting and editing.

Through my career in communications and marketing, working on diverse teams with projects large and small, I learned a great deal about how to work with others, often times with different thoughts, opinions and ideas.

My career has taught me about courage, the courage to take on large and complex projects. Often times these projects require skills I do not currently possess, but those which I know I will be able to learn. One of the most rewarding parts of my career is seeing the excitement amongst my team when we complete a video project that they didn't believe was possible, or not possible without hiring an outside agency.

Do you have any special qualifications that you feel would help you be particularly effective (i.e. work experience, volunteer experience, education, professional or organizational memberships, hobbies, etc.)?

When I chose to continue to make Moorhead my home after graduating from Concordia College, I knew I wanted to do more than just live in the FM metro - I wanted to be involved in it.

Most recently, in my position with the High Impact Institute and Dakota Medical Foundation, I was deeply involved in the execution of Giving Hearts Day 2021. My role in Giving Hearts Day was producing the all-day video livestreams, while delegating tasks and problem solving with my team. The outpouring of community support was tremendous and we raised more money than ever before with the added challenge of a pandemic when many in our community were the most in need.

In spring of 2020, I graduated with the Fargo-Moorhead Chamber of Commerce Leadership Class. As a part of this organization, I had the privilege to grow my leadership skills alongside 40 other motivated, passionate leaders. For my team's class project, we researched plastic waste with a focus on single-use shopping bags.

In 2017, I completed a four-year project in conjunction with a grant from The Arts Partnership to produce a time-lapse video highlighting a year in the life of the cities of Fargo-Moorhead. I chose to take on this project after watching time-lapse videos produced in New York and San Francisco. I was inspired, and I wanted to show the vast array of activities and sights that Fargo-Moorhead has to offer.

What are your ideas or observations on the role of the City Council

I believe in the power of local government, and that the growth in our community doesn't happen by accident. True growth happens through thoughtful and informed leadership, and Moorhead City Council is a cornerstone of that leadership.



When serving AFSCME Local 602, I serve on a board, serve as a steward, actively participate in meetings, work through celebrations and stressful situations, and build community among our membership.

Through my work at MSUM, I read and review numerous legal vendor contracts and enjoy working with our staff on the contracts to ensure needs are being addressed, and specifications are listed so we can move forward with the projects as discussed.

I have had the opportunity to help plan and execute the PB&J School Lunch Fundraiser in our Moorhead community for three years. The PB&J School Lunch Fundraiser was born of an idea shared over lunch between two friends and became an event that brought awareness to a gap in our system between families needing support, but not qualifying for the free & reduced lunch programs. The event raised tens of thousands of dollars for Moorhead families in need, brought local businesses and community members together on an issue, and helped enact positive change (MAPS school lunch policy regarding debt).

Through my philanthropy with the Hopkins PTAC, I spearheaded the founding of the Ellen Hopkins Elementary School Nature Play Park (EHES NPP), which I continue to this day. Beginning in Fall of 2015, the creation of the EHES NPP was a long, thorough process of listening and input sessions with community stakeholders, students, parents, and administrators. In Fall of 2016, this process lead us to expand to nine community gardens and plant 30 fruit trees in this space with educational opportunities for students and food for the community. I am extremely excited about the 100 fruit tree and bush plantings that will be happening this spring at MB Johnson park. This space will offer another opportunity for our community to come together, enjoy nature, and share in its bounty.

What are your ideas or observations on the role of the City Council?

City Council is the catalyst for community building in Moorhead and defines our role the region. City Council has a role in shaping the identity of Moorhead and I would like to be a leader in that quest. Given the activities and roles that I have been involved with, I believe that we can define and maintain a strong, positive, and inclusive culture within our community; City Council is a feature player in developing and maintaining the supportive, caring heart of a community. I prefer a servant leader model and look for those leaders within City Council. I believe that I am one of those leaders and would like to share and collaborate within City Council and our community. I believe that my style of servant leadership would complement the current City Council well, and together, we will continue to growth with Moorhead.
