2022 Rules and Guidelines

Vendors must abide by the following rules and guidelines:

- All vehicles and volunteers are strongly encouraged to dress in costume in the spirit of Halloween!
- Businesses are encouraged to pass out candy. Please indicate on registration sheet if you would like the City of Moorhead to purchase candy for you at a fee of \$10.
- Booth space is free if providing your own candy and not selling any items.
- The Monster Mash Trunk or Treat is an alcohol and tobacco-free event.
- Vehicles/booths must check in at the Information table to be assigned a spot.
- Vehicle/booth space is two parking spots. Vendor display and storage areas shall not extend beyond the space allowed.
- There will be no refunds due to inclement weather. Monster Mash Trunk or Treat will be canceled if Moorhead is in a severe weather warning. All cancelation decisions will be made at noon on the day of the event.
- The Trunk or Treat is held on city-owned property - all products must be family-friendly and inoffensive. Vehicles/booths may not be organized around political or religious themes. The Recreation Coordinator determines what can or cannot be sold.
- Supplies are the responsibility of the vendor/booth participant. No tables or chairs are provided.
- Vehicles/booths may begin setting up at 1:30 pm and must be ready by 4:30 pm. The event will end at 7 pm. You are asked to not leave the event early. Vendor/booth must be packed up and out of the ramp by 8 pm.
- Vendors are responsible to clean up the area they occupy and must maintain a clean and orderly area on all sides of their display.
- No pets are allowed in vendor booths, with the exception of service animals with proper documentation.
- Vendors are responsible for insuring their booth and personal property.
- The City of Moorhead and the Moorhead Center Mall will not be held responsible for theft or damage to your property.
- Recreation Coordinator has the responsibility to implement policy on all operations on the day of the event as the need arises.
- Please report any issues to the Recreation Coordinator directly.
- All vendors are responsible for obtaining a Minnesota tax ID number and all necessary permits or licenses for their booth.
- Request a Minnesota Tax ID number by calling 800-657-3605 or going to www.taxes.state.mn.us.
- All food vendors must apply for a temporary food permit through the Minnesota Department of Health. Please contact Clay County Environmental Health at 218.299.5002 for more information.

PENALTY — Operators who do not have Form ST19 or a similar written document from sellers can be fined a penalty of \$100 for each seller that is not in compliance for each day of the selling event.

Information for Sellers and Event Operators

Operators/organizers of craft, antique, coin, stamp or comic book shows; flea markets; convention exhibit areas; or similar events are required by Minnesota law to get written evidence that persons who do business at the show or event have a valid Minnesota tax ID number.

If a seller is not required to have a Minnesota tax ID number, the seller must give the operator a written statement that items offered for sale are not subject to sales tax.

All operators (including operators of community sponsored events and nonprofit organizations) must obtain written evidence from sellers.

Certain individual sellers are not required to register to collect sales tax if they qualify for the isolated and occasional sales exemption. To qualify, all the following conditions must be met:

- The seller participates in only one event per calendar year that lasts no more than three days;
- The seller makes sales of \$500 or less during the calendar year; and
- The seller provides a written statement to that effect, and includes the seller's name, address and telephone number.

This isolated and occasional sales provision applies to individuals only. It does not apply to businesses.
