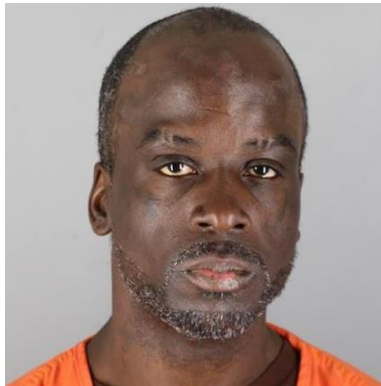

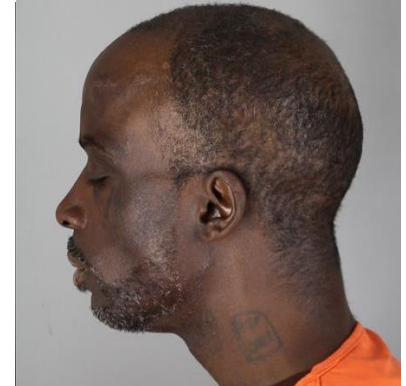

Offense: (2007, Goodhue Co) Andre Tolefree engaged in sexual contact against victim (female, age 17). Contact included oral and penile-vaginal penetration. Tolefree used force and a weapon (knife) to gain compliance. Tolefree met victim online prior to offense. (2005, St. Louis Co) Tolefree physically assaulted, restrained, and held victim (adult female) against her will. Victim was struck then threatened with a weapon (knife). Tolefree was known (boyfriend) to victim.

Other Predatory Offenses and/or Behavior: Convicted of Terroristic Threats for 2005 offense. Lengthy criminal history. History of substance abuse, mental health issues, and suicidal ideations.

Admitted to not taking medications and instead taking medical marijuana for paranoia. 02/12/2021 - Cut off GPC bracelet; Engaged in phone sex with a female he met on phone chat lines. 05/08/2013 - Disobeying a direct order; Disorderly conduct; Fighting 04/16/2013 - Cut GPS bracelet; Terminated from residential programming due to absconding; Arrested in Illinois. 08/30/2012 - Failure to comply with electronic surveillance, failure to complete residential programming as directed, and for failure to remain within the State of Minnesota. 07/11/2011 - Failure to comply with electronic surveillance as directed by agent/designee. 07/26/2007 - For CSC-4th degree. 11/21/2006 - Failure to contact agent prior to release from custody, and by new conviction.
