**Professionalism:** Being part of a highly skilled, competent fire department that portrays good character and is respectful to everyone.


**Responsibility:** Being accountable for the things within our member's or our department's control.

Cooperation: Working together to achieve common goals as one department.


**Dedication:** Devoted to the fire department, its members and the community to provide the highest level of service that is reasonably achievable.


# **ORGANIZATIONAL CHART**



## SUPPRESSION REPORT

There were 3,294 emergency responses in 2015. This is an increase of 32.29%, as compared to the total of 2,490 in 2014. This large change in responses was due in part to a policy shift for emergency medical calls. For the previous two years, dispatchers asked a series of questions to screen and classify the nature and severity of the incident. Moorhead Fire did not respond to medical calls that involved little to no risk of being life-threatening. An unintended consequence of this was a considerable delay in dispatching fire to life-threatening medicals while the series of questions were being asked. The procedure was changed to dispatch fire after only a few questions to reduce response times while additional questions were being asked. We responded to more minor medicals, but decreased our response time to serious medicals where time is critical. The stacked bar graph below represents the 10-year trend of our incidents. More detailed incident response information may be found in the NFPA report at the end of this annual report.


