An unplatted parcel located in Northwest Quarter of Section 23 of Township 139 North, Range 48 West of the Fifth Principal Meridian, Clay County, Minnesota beginning 80 feet east of the Northeast corner of Lot 5 of Block 3 of McCARA First Addition; thence East 700 feet, thence South 500 feet; thence West 700 feet; thence North 500 feet to the point of beginning.
